The response by the PIO is not only incomplete but chooses to willfully misunderstand the query. Moreover his response is also mendacious.



- and thereafter update these publications every year;
- (c) publish all relevant facts while formulating important policies or announcing the decisions which affect public;
- (d) provide reasons for its administrative or quasi-judicial decisions to affected persons.
- (2) It shall be a constant endeavour of every public authority to take steps in accordance with the requirements of clause (b) of sub-section (1) to provide as much information suo 'notu to the public at regular intervals through various means of communications, including internet, so that the public have minimum resort to the use of this Act to obtain information.
- (3) For the purposes of sub-section (1), every information shall be disseminated widely and in such form and manner which is easily accessible to the public.
- (4) All materials shall be disseminated taking into consideration the cost effectiveness, local language and the most effective method of communication in that local area and the information should be easily accessible, to the extent possible in electronic formst with the Central Public Information Officer or State Public Information Officer, as the case may be, available free or at such cost of the medium or the print cost price as may be prescribed.

Explanation.—For the purposes of sub-sections (3) and (4), "disseminated" means making known or communicated the information to the public through notice boards, newspapers, public announcements, media broadcasts, the internet or any other means, including inspection of offices of any public authority.

c) PIO seems to have not even seen the web address www.megplanning.gov.in, where he expected me to find section 4 disclosure. Forget disclosure for Invest Meghalaya Authority, this web address does not even have section 4 disclosures for Department of Planning, Investment Promotion and Sustainable Development itself. In the whole website there is no tab or link of Right to Information disclosure including those that can inform the citizens about the Public Information Officer and Appellate Authority (as per 07/08/2024)



Moreover, clicking on the link for Invest Meghalaya Authority takes you to the page that does not have section 4 disclosures but merely a list of clickable notifications.

This response is incorrect as the public authority Invest Meghalaya Authority was not approved by the cabinet but was instituted by an Act of Legislature, namely Meghalaya State Investment Promotion & Facilitation Act, 2024 (Act No. 6 of 2024) that received the assent of the Governor on 12th March 2024 and was gazetted on 14th March 2024.

Moreover, this act in the form of a Bill would have been placed before the cabinet for deliberation before being placed in the Assembly. Proposal for the bill would have come from a public authority, there would have been discussions, opinions, meetings regarding the law and draft law, all of this is covered under my query and is liable to be disclosed.

Also PIO is referring to which section of section 8(1) to deny me information?

If it is section 8(1)(i) then also PIO is misreading the section to blanket deny me the information as sought by me.

The section says that

(i) cabinet papers including records of deliberations of the Council of Ministers, Secretaries and other officers:

Provided that the decisions of Council of Ministers, the reasons thereof, and the material on the basis of which the decisions were taken shall be made public after the decision has been taken, and the matter is complete, or over:

Provided further that those matters which come under the exemptions specified in this section shall not be disclosed;

As any reading of the section makes it clear that only cabinet papers including records of deliberations' are exempt from disclosure. What is not exempt from disclosures are Notes and materials based on which decisions are taken are to be proactively disclosed after the decision has been taken. As you know there must be multiple decisions about the law and Invest Meghalaya Authority and all the decisions and material based on which such decisions have been taken including Notes and advice have to be disclosed.

- (c) publish all relevant facts while formulating important policies or announcing the decisions which affect public;
- (d) provide reasons for its administrative or quasi-judicial decisions to affected persons.
- (2) It shall be a constant endeavour of every public authority to take steps in accordance with the requirements of clause (b) of sub-section (1) to provide as much information suo.'notu to the public at regular intervals through various means of communications, including internet, so that the public have minimum resort to the use of this Act to obtain information.
- (3) For the purposes of sub-section (1), every information shall be disseminated widely and in such form and manner which is easily accessible to the public.
- (4) All materials shall be disseminated taking into consideration the cost effectiveness, local language and the most effective method of communication in that local area and the information should be easily accessible, to the extent possible in electronic formst with the Central Public Information Officer or State Public Information Officer, as the case may be, available free or at such cost of the medium or the print cost price as may be prescribed.

Explanation.—For the purposes of sub-sections (3) and (4), "disseminated" means making known or communicated the information to the public through notice boards, newspapers, public announcements, media broadcasts, the internet or any other means, including inspection of offices of any public authority.

c) PIO seems to have not even seen the web address www.megplanning.gov.in, where he expected me to find section 4 disclosure. Forget disclosure for Invest Meghalaya Authority, this web address does not even have section 4 disclosures for Department of Planning, Investment Promotion and Sustainable Development itself. In the whole website there is no tab or link of Right to Information disclosure including those that can inform the citizens about the Public Information Officer and Appellate Authority (as per 07/08/2024)



Moreover, clicking on the link for Invest Meghalaya Authority takes you to the page that does not have section 4 disclosures but merely a list of clickable notifications.



PIO's reply therefore is wilfully wrong.

I appeal that I should be given section 4 disclosures of Invest Meghalaya Authority as per the RTI Act 2005.

This response is incorrect as the public authority Invest Meghalaya Authority was not approved by the cabinet but was instituted by an Act of Legislature, namely Meghalaya State Investment Promotion & Facilitation Act, 2024 (Act No. 6 of 2024) that received the assent of the Governor on 12th March 2024 and was gazetted on 14th March 2024.

Moreover, this act in the form of a Bill would have been placed before the cabinet for deliberation before being placed in the Assembly. Proposal for the bill would have come from a public authority, there would have been discussions, opinions, meetings regarding the law and draft law, all of this is covered under my query and is liable to be disclosed.

Also PIO is referring to which section of section 8(1) to deny me information?

If it is section 8(1)(i) then also PIO is misreading the section to blanket deny me the information as sought by me.

The section says that

(i) cabinet papers including records of deliberations of the Council of Ministers, Secretaries and other officers:

Provided that the decisions of Council of Ministers, the reasons thereof, and the material on the basis of which the decisions were taken shall be made public after the decision has been taken, and the matter is complete, or over:

Provided further that those matters which come under the exemptions specified in this section shall not be disclosed;

As any reading of the section makes it clear that only cabinet papers including records of deliberations' are exempt from disclosure. What is not exempt from disclosures are Notes and materials based on which decisions are taken are to be proactively disclosed after the decision has been taken. As you know there must be multiple decisions about the law and Invest Meghalaya Authority and all the decisions and material based on which such decisions have been taken including Notes and advice have to be disclosed.

For instance if Invest Meghalaya Authority has written to PWD querying about the land it holds in Shillong or elsewhere or to Soil Conservation department regarding parcels of land it holds for instance in Byrnihat or Urban Affairs department regarding land parcels in Shillong or Tura then all of such correspondences along with their enclosures need to be disclosed.

Case record put up today:

- 1. The Appellant Smt. Angela Rangad assisted by Shri. Tarun Bhartiya, were present for the hearing today. Shri. K. Hynniewta, Chief Administrative Officer, Invest Meghalaya Authority and Smt. D. Sayo, PIO and Under Secretary, Planning (A) Department were also present.
- 2. The Appellant informed that on 1-07-2024, she had lodged an RTI application with the PIO of the Invest Meghalaya Authority, Government of Meghalaya and reply was made only on the 5-08-2024 after a gap of six days from the stipulated time of thirty days provided under the Act. Further, the reply was not satisfactory and the Appellant was also not given the right to inspect the documents as requested in her RTI application dated 1-07-2024.
- 3. The Commission, during the hearing examined the queries and directed the Chief Administrative Officer to provide the documents required under query (1) and allow the Appellant to inspect the documents. 17-12-2024 has been fixed as the date of inspection. The Chief Administrative Officer is to liaise with the Appellant for according her time for inspection.
- 4. On query (2) the denial under Section 8 (i) of RTI Act is incorrect, as the proposal for setting up the authority has already been approved by Cabinet and proviso to Section 8 (i) of the RTI Act, allows for the same. Further, the Invest Meghalaya Authority was instituted by an Act of Legislature, namely Meghalaya State Investment Promotion & Facilitation Act, 2024 (Act No. 6 of 2024) that received the assent of the Governor on 12th March, 2024 and was gazetted on 14th March, 2024. The Chief Administrative Officer is directed to provide the Cabinet memo and the approval thereof including relevant documents if any, in setting up of the Authority.
- 5. Query (3) relates to correspondences carried out between Invest Meghalaya Authority and various Government Departments on the proposed transfer of Government land to the Authority. The Chief Administrative Officer stated that there has been no transfer of land in the Authority, to which the Appellant countered the statement with a document bearing the signature of the Chief Administrative Officer himself. She alleged that such perjury should not be tolerated by the Commission. On perusal of the document, it is found that there have been correspondences between Invest Meghalaya Authority and Soil & Water

Conservation Department under the signature of the Chief Administrative Officer. Although there is no transfer of land but there exist a correspondence which Invest Meghalaya Authority had issued to Soil & Water Conservation Department relating to the subject matter.

The Chief Administrative Officer is hereby cautioned not to issue such irresponsible statements in future without verifying facts. The Chief Administrative Officer is directed to supply the correspondences if any; to the Appellant, free of cost.

6. Compliance report should be filed by PIO and Under Secretary, Planning Department & CAO, Invest Meghalaya Authority by 6-01-2025.

- 2. As you must have seen that my application includes exercising my Right to Inspection

Please provide me with the following information under the Right to Information Act 2005. I would take the copies of the information after inspecting the original documents in their original file cover.

The RTI Act 2005 in section 2(j) states

- (l) "right to information" means the right to information accessible under this Act which is held by or under the control of any public authority and includes the right to—
- (i) inspection of work, documents, records;
- (ii) taking notes, extracts or certified copies of documents or records;
- (iii) taking certified samples of material;
- (iv) obtaining information in the form of diskettes, floppies, tapes, video cassettes or in any other electronic mode or through printouts where such information is stored in a computer or in any other device;

And by not letting me inspect constitutes a denial of information as per the RTI Act 2005. Therefore I appeal that my Right to Inspect as per the RTI Act 2005 is restored.

- a) Invest Meghalaya Authority is not just a subordinate institution set up under the Department of Planning, Investment Promotion and Sustainable Development but an independent authority instituted by an Act of Legislature, namely Meghalaya State Investment Promotion & Facilitation Act, 2024 (Act No. 6 of 2024) that received the assent of the Governor on 12th March 2024 and was gazetted on 14th March 2024.
- b). As you are aware that section 2(h)(c) defines public authority as:
 - (h) "public authority" means any authority or body or institution of self- government established or constituted—
 - (c) by any other law made by State Legislature;

And therefore Invest Meghalaya Authority is a public authority that has to fulfill its obligations as a Public Authority and make its own statutory suo-moto disclosures as per the section 4 of the RTI Act 2005. Section 4 states:



- (b) publish within one hundred and twenty days from the enactment of this Act,—
- (i) the particulars of its organisation, functions and duties;
- (ii) the powers and duties of its officers and employees;
- (iii) the procedure followed in the decision making process, including channels of supervision and accountability;
- (iv) the norms set by it for the discharge of its functions;
- (v) the rules, regulations, instructions, manuals and records, held by it or under its control or used by its employees for discharging its functions;
- (vi) a statement of the categories of documents that are held by it or under its control;
- (vii) the particulars of any arrangement that exists for consultation with, or representation by, the members of the public in relation to the formulation of its policy or implementation thereof
- (viii) a statement of the boards, councils, committees and other bodies consisting of two or more persons constituted as its part or for the purpose of its advice, and as to whether meetings of those boards, councils, committees and other bodies are open to the public, or the minutes of such meetings are accessible for public;

- (xiv) details in respect of the information, available to or held by it, reduced in an electronic form;
- (xv) the particulars of facilities available to citizens for obtaining information, including the working hours of a library or reading room, if maintained for public use;

- (d) provide reasons for its administrative or quasi-judicial decisions to affected persons.
- (2) It shall be a constant endeavour of every public authority to take steps in accordance with the requirements of clause (b) of sub-section (1) to provide as much information suo 'notu to the public at regular intervals through various means of communications, including internet, so that the public have minimum resort to the use of this Act to obtain information.
- (3) For the purposes of sub-section (1), every information shall be disseminated widely and in such form and manner which is easily accessible to the public.
- (4) All materials shall be disseminated taking into consideration the cost effectiveness, local language and the most effective method of communication in that local area and the information should be easily accessible, to the extent possible in electronic format with the Central Public Information Officer or State Public Information Officer, as the case may be, available free or at such cost of the medium or the print cost price as may be prescribed.

Explanation.—For the purposes of sub-sections (3) and (4), "disseminated" means making known or communicated the information to the public through notice boards, newspapers, public announcements, media broadcasts, the internet or any other means, including inspection of offices of any public authority.

c) PIO seems to have not even seen the web address www.megplanning.gov.in, where he expected me to find section 4 disclosure. Forget disclosure for Invest Meghalaya Authority, this web address does not even have section 4 disclosures for Department of Planning, Investment Promotion and Sustainable Development itself. In the whole website there is no tab or link of Right to Information disclosure including those that can inform the citizens about the Public Information Officer and Appellate Authority (as per 07/08/2024)



Moreover, clicking on the link for Invest Meghalaya Authority takes you to the page that does not have section 4 disclosures but merely a list of clickable notifications.

This response is incorrect as the public authority Invest Meghalaya Authority was not approved by the cabinet but was instituted by an Act of Legislature, namely Meghalaya State Investment Promotion & Facilitation Act, 2024 (Act No. 6 of 2024) that received the assent of the Governor on 12th March 2024 and was gazetted on 14th March 2024.

Moreover, this act in the form of a Bill would have been placed before the cabinet for deliberation before being placed in the Assembly. Proposal for the bill would have come from a public authority, there would have been discussions, opinions, meetings regarding the law and draft law, all of this is covered under my query and is liable to be disclosed.

Also PIO is referring to which section of section 8(1) to deny me information?

If it is section 8(1)(i) then also PIO is misreading the section to blanket deny me the information as sought by me.

The section says that

(i) cabinet papers including records of deliberations of the Council of Ministers, Secretaries and other officers:

Provided that the decisions of Council of Ministers, the reasons thereof, and the material on the basis of which the decisions were taken shall be made public after the decision has been taken, and the matter is complete, or over:

Provided further that those matters which come under the exemptions specified in this section shall not be disclosed:

As any reading of the section makes it clear that only cabinet papers including records of deliberations' are exempt from disclosure. What is not exempt from disclosures are Notes and materials based on which decisions are taken are to be proactively disclosed after the decision has been taken. As you know there must be multiple decisions about the law and Invest Meghalaya Authority and all the decisions and material based on which such decisions have been taken including Notes and advice have to be disclosed.
